- Newly enrolled customers need to have permission to operate by December 1, 2023 in order to be eligible to participate in the ConnectedSolutions program.
- Customers for whom Eversource has received applications on or prior to December 1, 2023 will receive performance incentives earned for 2023 and 2024 summer DR seasons
- Eversource intends to file with DEEP for further funding for ConnectedSolutions batteries for the 2025-2027 plan term, but whether or not that funding is authorized is at the discretion of DEEP & PURA, so there is no guarantee
